

## **TERMS AND CONDITIONS**

### **1. General Terms and Conditions**

Athletes' parents/guardians are solely responsible for them arriving at and leaving from the facilities (Leonteios School) as well as attending and leaving from any other of the Academy's activities at the specified times announced by the A.O. Leonteiou Academy.

b) Parents/guardians can watch the training sessions that take place at the the Leonteios School from the facility's stands

c) Any change in the times of training sessions or games will be made known to the athletes' parents/guardians via e-mail as registered on the application form.

d) Equipping the athletes with this season's (2019-20) A.O. Leonteiou apparel is required for their participation in training sessions and games, as detailed on page 2 of this document.

e) Every athlete that registers in the Academy is required to obtain the necessary sports equipment in order to be able to participate in the Academy's activities.

f) A.O. Leonteiou bears no responsibility for any loss of personal items or clothing of athletes, who will have to avoid bringing with them items of value or large amounts of money.

### **2. Membership**

a) The membership in AO Leonteiou is 10 months (September 2019-June 2020).

b) Payment of membership fees is required for the entire 10 months that A.O. Leonteiou will be operating.

c) Paying the membership **by the 5th day of each month** (see Article 5) is a basic requirement and condition for the athletes' participation in the activities of A.O. Leonteiou. It should be noted that the last payment will be made until May 5<sup>th</sup> and will include paying off the membership for the months of May and June.

d) No refunds will be made under any circumstances.

### **3. Cost of Registration, Monthly Membership Fees and Sports Equipment**

The cost of the monthly membership fees and the sports equipment for the athletes of A.O. Leonteiou varies according to each class:

## **REGISTRATIONS**

Registration costs include the ESKA medical sticker for athletes with a bulletin (age 2001 to 2009) and the supply of sports equipment that is compulsory for all ages:

- -For athletes with date of birth from 2001-2009: Reversible training uniform, reversible game uniform, warm up, matching tracksuit and gym bag.

-For athletes with date of birth 2010: Reversible training uniform, warm up, matching tracksuit and backpack.

-For athletes with date of birth 2011-2014: Reversible training uniform, matching tracksuit and backpack.

It is clarified that applying for the ESKA medical card is now required with reregistration or with a new registration, it costs 15 euros and concerns the classes between 2004 and 2009.

Payment of the registration fees can be made in three monthly installments (September 2019 – November 2019).

-For athletes with date of birth from 2001-2009: September 2019: 50,00€, October 2019: 50,00€, November 2019: 30,00€

-For athletes with date of birth 2010: September 2019: 50,00€, October 2019: 25,00€, November 2019: 25,00€

-For athletes with date of birth 2011-2014: September 2019: 30,00€, October 2019: 30,00€, November 2019: 25,00€

## **4. Special discounts**

The lump sum repayment of the annual subscription fee in September is accompanied by a 10% discount.

The children of alumni and employees of the Leonteios School of Patisia are eligible to preferential rates for their participation in the camp.

## **5. Payment of membership**

Payment of the registration and membership for the 2019-20 season will have to be made strictly within the dates listed below:

1<sup>st</sup> payment – for the registration: from June to September 2019

2<sup>nd</sup> payment – for September: September 1-5, 2019

3<sup>rd</sup> payment – for October: October 1-5, 2019

4<sup>th</sup> payment – for November: November 1-5, 2019

5<sup>th</sup> payment – for December: December 1-5, 2019

6<sup>th</sup> payment – for January: January 1-5, 2020

7<sup>th</sup> payment – for February: February 1-5, 2020

8<sup>th</sup> payment – for March: March 1-5, 2020

9<sup>th</sup> payment – for April: April 1-5, 2020

10<sup>th</sup> payment – for May/June: May 1-5, 2020

Payment should be made either through bank deposit or via debit/credit card (POS) or with cash at the A.O. Leonteiou front desk.

In case of payment through bank deposit, the depositor is requested to fill in the athlete's name on the statement of the deposit slip.

#### **6. Discontinuation of Membership**

**a)** In the event of a decision to discontinue the membership, the athlete or his/her parent/guardian must inform the academy in writing via e-mail at [aoleonteios@eurohoops.net](mailto:aoleonteios@eurohoops.net). If and insofar he/she has fully paid off his/her membership and has no pending financial matters up to the month of his/her cancellation, A.O. Leonteiou will deregister him/her as decided by him/her or his/her parent/guardian.

**b)** If the athlete or his/her parent/guardian does not inform the academy of his/her decision to discontinue in writing via e-mail at [aoleonteios@eurohoops.net](mailto:aoleonteios@eurohoops.net), the athlete will remain registered at

A.O. Leonteiou regardless of their absence from its activities and the length of that absence (and will owe the corresponding membership fees mentioned above).

**c)** For every deregistration of an athlete, A.O. Leonteiou reserves the right to replace him/her with a new one. An athlete who has been deregistered does not have the right to re-register within the same season. In the event of an application for re-registration in the next season, the athlete is required to pay the membership fees for **one (1) additional month** after the already paid-for month of his/her deregistration, if the membership had been cancelled before the middle of the season (January). In case of a cancellation of the membership after the middle of the season (February), he/she is required to pay the membership fees for **two (2) additional months** after the already paid-for month of his/her deregistration.

**d)** If an athlete has not been deregistered from A.O. Leonteiou but wishes to, or cannot – for reasons other than the ones listed in Article 7, paragraph b – train for any length of time, he/she is not exempt from the obligation to pay the membership fees for the period of their absence.

**e)** Failure to pay the above membership fees within the above deadlines gives A.O. Leonteiou the right to immediately and with no respect to deadlines terminate the contract for the provision of sports services to the athlete and to immediately deregister him/her.

## **7. Medical Matters**

**a)** Every athlete that wishes to participate in A.O. Leonteiou is required to be examined by a Cardiologist, and to present the athlete's Health Card.

**b)** The training sessions and home games of A.O. Leonteiou at its facilities (Leonteios School) are conducted in the presence of First Aid trained personnel. Therefore, A.O. Leonteiou cannot be held responsible for any injury or other incident in the course of its activities or for further coverage of medical expenses. A.O. Leonteiou is not responsible for any incidental and/or consequential damages and/or moral damages and/or mental anguish of its athletes.

**c)** In the case of an athlete's absence from the activities of A.O. Leonteiou due to injury or illness, he/she is not exempt from the obligation to pay membership fees.

## **8. Removal from A.O. Leonteiou**

- a) In the event of improper behavior on the part of an athlete's parent/guardian, A.O. Leonteiou reserves the right to send him/her away or not allow them to attend training sessions or games. Improper behavior is defined as any act or misconduct that is not consistent with the philosophy of A.O. Leonteiou and concerns – among other things – behavior in the stands, behavior towards other athletes' parents, the Eurohoops Academy or other clubs, towards the coaches and staff of A.O. Leonteiou, as well as to third parties.
- b) Failure to comply with the regulations and the instructions of the staff of A.O. Leonteiou on the part of a parent/guardian may result in the removal of the athlete from its classes without notice and without any question of membership fee reimbursement or any other compensation.

## **9. Audiovisual Material and Intellectual Property**

- a) Any kind of photography, video or sound recording on the premises of A.O. Leonteiou without the permission of A.O. Leonteiou is forbidden.
- b) When registering an athlete, you consent to the use and exploitation by A.O. Leonteiou and the "Eurohoops Greece IKE" company of any audiovisual material related to your minor child, as it arises in the course of his/her activities in the academy.

## **10. Personal Data**

**10.1 Identification Details, Birth Certificate, Photographs:** In accordance with the sports services contract, A.O. Leonteiou will maintain in electronic and written form the athlete's and guardian's details as stated in the "Athlete Application Form." The collection of this data will be made in order to facilitate communication with the athlete and his/her guardian for any eventuality (e.g. in case of a change in the schedule of training sessions, games etc.). In this regard, a document and possibly an electronic record of the submitted birth certificate will be kept in order to be able to easily prove the athlete's date of birth, his/her proper integration into the relevant class according to age and possibly his/her legal participation in the appropriate game divisions according to age. In addition, a

document and electronic file of the athlete's photos will be kept so that, in accordance with the relevant contract, they can be identified at all times (recognized by the coaches etc.). Finally, a record will be kept of the days and times of the athlete's participation in sports activities as well as his/her athletic performance in games and/or training sessions (especially statistics of athletic performance such as playing time, made/missed shots, etc.), though no biometric data will be kept. This data will be kept for a maximum of five (5) years after the termination/expiry of the contract. An exception to this is only the statistical data, which will be kept indefinitely in order to maintain a history of the team's and the player's statistics.

**10.2 Medical Certificates:** A.O. Leonteiou will maintain a document and electronic record of the athlete's Medical Certificate, which will be submitted when they apply and/or renew the sports services contract. Such processing is necessary for the safeguarding of the Athlete's vital health interest and is, at the same time, a legal obligation of A.O. Leonteiou. This data will be kept for a maximum of five (5) years after the termination/expiry of the relevant contract.

**10.3 Audiovisual Material:** When submitting the "Athlete Application Form," the athlete's Guardian automatically gives his/her consent for the Academy to maintain an electronic record of and to use audiovisual material the athlete will participate in, in the context of his/her games or training sessions, as outlined in paragraph 9 above.

This material may be used: (a) so the staff of A.O. Leonteiou can monitor the athlete's performance, (b) for publication on the internet (on the official site or on social media pages of A.O. Leonteiou and its affiliates, such as, associates, sponsors, etc.). This processing will take place for a maximum of twenty (20) years after the termination/expiry of the relevant contract so that, if there is the possibility of creating a video of the athlete's progress over the years, there will be a record of it.

**10.4 Online updates regarding the news and activities of the Eurohoops Academy:** When submitting the "Athlete Application Form," the athlete's Guardian automatically agrees to receive

updates regarding the news and activities of the A.O. Leonteiou at the e-mail address they have provided on the relevant form. This processing will take place for a maximum of five (5) years after the termination/expiry of the relevant contract.

**10.5 Other information:** The Guardian or the athlete himself/herself, under the conditions of the relevant legislation, has the right to submit at any time to A.O. Leonteiou a request for access and correction or deletion of the above data, or for limiting the processing of this data or their opposition to that processing or for the portability (transfer) of the data to a third party. In any case, the Guardian or the athlete himself/herself, have the right to report to any relevant authorities any violation of the existing provisions concerning their personal data. It is clarified that, from the above, the data under paragraphs 10.1, 10.2 and 10.3 are necessary for the execution of the service contract. In the context of the processing of the above data, there will be no automated decision-making and/or profiling of the athlete. The data under 10.1 may be forwarded to third parties and, in particular, either to basketball authorities under the requirements of the relevant regulations (e.g. the organizing authority ESKA), or to rival teams only when that is required by the relevant regulations.

All of the above data will under no circumstances be transferred to a third country (outside the EU) or to an international organization. With regard to the above, it is clarified that A.O. Leonteiou is the Data Processor. Its full and precise company name is “A.O. Leonteiou” and its contact details are listed below.

The main sports venue where training sessions will take place is located in Patisia, Attica (Neigi 17), The Head of Data Processing is located at Neigi 17, Patisia, Attica. The legal representative of the Head of Data Processing is the President of its Board of Directors, Mr. Fr.
