



Terms and Conditions of Participation Easter Camps 2025

(version 20/03/2025)

I. General Terms

This document incorporates the contractual terms between the athlete (represented by their guardian in case they are under 18 years of age) and the sports club under the name Eurohoops Academy Leonteios, based in Patissia, Athens (17 Neygi Street), legally represented by the Chairman of the Board, Mr. Rafa Escola. It is certified that the athlete is in good health and deemed capable of participating in intensive sports activities, as verified by a sports fitness certificate which must be submitted before the **athlete's** participation in these activities. If the athlete fails to **submit** the above document, they will not be allowed to participate in any sports activity.

- The amount corresponding to each participation must be deposited into the following account or paid by the court's secretariat without exception, at least 5 days before the start of each Camp.
- Any participant must comply with and follow the Camp rules.
- Failure to accept the terms of participation, failure to sign the Athlete

Participation Form for each Camp, failure to submit the documents mentioned therein, or failure to prepay the relevant participation amount according to these terms, means no contract is formed, without any claim by the participant. If the participant withdraws after the contract is formed, **they** are entitled to a refund of the amount paid, excluding start-up and organizational costs (15% of the total participation amount). In case of withdrawal during the Camp, the organizer is not obliged to refund any amount.

- By submitting my child's information and accepting their participation in the Camp, I hereby declare that I fully and unconditionally accept the terms of this document.

II. Participation Cost for Easter Camps 2025:

Fundamentals Camp: Period A: 14/04 - 17/04: €120/period, Period B: 22/04 - 25/04: €120/period.

Optional transport from Kifissia, 24 Evrota Street to Leonteios: €60/period. The gathering time at Evrota 24 is 08:00 and the return time is 13:45-55. If combined with Junior Shot Mechanics, transport cost is €75/period.

Junior Shot Mechanics: Period A: 14/04 - 17/04: €30/period, Period B: 22/04 - 25/04: €30/period.

€27/period if combined with Fundamentals. Optional transport from Kifissia, 24 Evrota Street to Leonteios: €60/period. The gathering time at Evrota 24 is 12:00 and the return time is 14:45-55. If combined with Fundamentals, transport cost is €75/period.



Offensive Skills Lab: Period A: 14/04 - 16/04: €90/period, Period B: 23/04 – 25/04: €90/period

Shooting Lab: Period A: 14/04 - 16/04: €40/period, Period B: 23/04 - 25/04: €40/period. €36/period if combined with Offensive Skills Lab.

For members of Eurohoops Academy Leonteios for the 2024-2025 season, a 10% discount on the initial price is provided.

- In case of family participation for Eurohoops Academy Leonteios members for the 2024-2025 season, the second member receives a 15% discount and the third member 20%.
- For Leonteios students, children of Leonteios alumni, and children of Leonteios staff, a 10% discount is provided.
- In case of family participation for Leonteios students, children of Leonteios alumni, and children of Leonteios staff, the second member receives a 15% discount and the third member 20%.
- In case of family participation (general), the second member receives a 10% discount and the third member 15%.
- For the Fundamentals Camp, the availability of bus transport will be finalized depending on the number of interested participants.

III. Payment Methods

Payment should be made either by bank deposit, debit/credit card (POS), or cash at the Eurohoops Academy Leonteios secretariat. In case of bank deposit, the depositor is requested to state the athlete's name in the deposit reason.

IV. Personal Data

IV 1. Personal Information:

In execution of the sports services contract, Eurohoops Academy Leonteios will maintain the athlete's and guardian's information (as stated in the "Athlete Participation Form") in both digital and paper format. This information will be collected to facilitate communication with the athlete and guardian (e.g., in case of training schedule changes). Records will also be kept regarding the days and times of the athlete's participation and their athletic performance during training (e.g., shooting statistics). No biometric data will be stored. Data will be retained for a maximum of five (5) years after the end of the contract.



IV 2. Medical Certificates:

Eurohoops Academy Leonteios will store in both digital and paper format the Medical Certificate submitted upon contract signing or renewal. This process is necessary to safeguard the athlete's vital health interests and is also a legal obligation. Data will be retained for a maximum of five (5) years after the end of the contract.

IV 3. Audio-Visual Material:

By completing the "Athlete Participation Form," the guardian automatically consents to the storage and use of audio-visual material featuring the athlete during training. This material may be used: for performance monitoring by Eurohoops Academy Leonteios staff, (b) for publication on the Eurohoops Academy Leonteios official website (aoleonteios.eurohoops.net) or social media channels, as well as eurohoops.net. This process will be valid for up to ten (10) years after contract termination to allow for potential compilation of progress videos. Consent may be revoked by the guardian or athlete at any time by submitting a statement to Eurohoops Academy Leonteios.

IV 4. Email Updates:

The guardian may choose on the "Athlete Participation Form" whether to consent to receiving email updates about news and activities of Eurohoops Academy Leonteios, Basketball Incubation, and eurohoops.net (Eurohoops Greece IKE, based at Leoforos Marathonos 1, Anoiksi, GEMI No. 141930201000), which may include sponsor messages. This processing will last for up to ten (10) years after contract termination. Consent may be withdrawn at any time by notifying Eurohoops Academy Leonteios.

IV 5. Other Information:

The guardian or athlete has the right, under applicable law, to submit a request to Eurohoops Academy Leonteios for access, correction, deletion, restriction, objection to processing, or portability of their data. They may also lodge a complaint with a competent authority for any violation. Data from IV 1, IV 2, and IV 3 is essential for contract execution. No automated decision-making or profiling will take place. The email data in IV 4 will not be transferred outside the EU or to any international organization. Eurohoops Academy Leonteios is the Data Controller, with the main venue at Patissia, Athens, and headquarters at 17 Neygi Street. The legal representative is Mr. Rafa Escola, Chairman of the Board.
