



## **TERMS OF ATHLETE PARTICIPATION**

### **(ISSUE DATE: 2 JUNE 2025)**

#### **General Terms of Participation**

- a) The parents or legal guardians of the athletes shall bear sole responsibility for ensuring the arrival and departure of the athletes to and from the premises of the Leonteios School of Athens, as well as for their timely attendance and departure from all other activities of the Academy, in accordance with the official schedule as announced by Eurohoops Academy Leonteios.
- b) Parents and/or legal guardians shall be permitted to attend training sessions held at Leonteios, provided they do so from the designated spectator stands of the sports facility.
- c) Any modification to the schedule of training sessions or matches shall be communicated to the athletes and their parents/legal guardians via the "Myteam" application, email (as provided in the registration form), SMS, or through announcements posted on the official website of Eurohoops Academy Leonteios (<https://aoleonteios.eurohoops.net/>).
- d) Each athlete enrolled in the Academy is required to obtain the necessary athletic gear and equipment in order to participate in Academy activities.
- e) Eurohoops Academy Leonteios accepts no liability whatsoever for the loss of personal belongings or clothing of athletes. Athletes are advised not to bring items of value or large sums of money to Academy premises.

#### **Membership Subscription**

- a) The membership subscription to Eurohoops Academy Leonteios is valid for a period of ten (10) months, covering the entire competitive season of 2025–2026 (from 1 September 2025 to 30 June 2026), and its full payment is mandatory for the entire duration. Payment may be made in monthly installments, as detailed below, without altering the ten-month term of the subscription.
- b) Subscription fees for the 2025–2026 competitive season must be paid strictly by the 5th calendar day of each month. The total period of participation and corresponding financial obligation shall span ten (10) months, from September through June. It is noted that the subscription fee for the month of June is to be paid concurrently with that of May.
- c) Under no circumstances shall any refund be issued.

#### **Registration Fees, Monthly Subscription Fees, and Athletic Equipment Costs**

The cost of membership subscription and athletic equipment for athletes of Eurohoops Academy Leonteios varies depending on the division.

#### DISCOUNTS:

- In cases of family enrollment (i.e., more than one athlete from the same family), a discount of five euros (5€) shall be applied to each individual subscription, provided that all participating athletes remain active members of the Academy.
- Any athlete of Eurohoops Academy Leonteios who refers a new athlete from outside the Academy, and whose registration is successfully completed, shall be entitled to a referral discount. Both the referring athlete and the referred athlete shall benefit from a reduced monthly subscription fee, which shall be set at either fifty euros (50€) or forty-five euros (45€), as long as both athletes maintain active participation in the Academy.

#### RE-REGISTRATION:

This provision applies to athletes who were registered members of the Eurohoops Academy during the 2024–2025 season. The re-registration fee for the 2025–2026 season includes the cost of the new, age-appropriate athletic equipment, which is mandatory for participation.

#### NEW REGISTRATIONS:

The registration fee includes a base charge of fifteen euros (15€), as well as the cost of mandatory athletic equipment, which applies to all age groups.

- For athletes born between 2008 and 2016, the equipment package includes: Training Double-Face jersey, Game Double-Face jersey, Warm-up top, Tracksuit set, Training backpack
- For athletes born between 2017 and 2020: Training Double Face jersey, Tracksuit set and backpack.

The total amount for the registration fee and athletic gear can be paid in three monthly installments, from September 2025 through November 2025, as follows:

- New athletes born between 2008 and 2016: September 2025: 70€, October 2025: 70€, November 2025: 50€
- New athletes born between 2017 and 2020: September 2025: 50€, October 2025: 40€, November 2025: 30€

## 1. Special discounts

If the annual subscription and registration fee are paid in full by the end of September 2025, a 5% discount will be applied. Payment can also be made by credit card in up to 12 interest-free installments.

## 2. Subscription Payment

The annual subscription fee for the 2025–2026 season can be paid in monthly installments as follows:

- 1st Payment → Registration or re-registration fee: September 2025
- 2nd Payment → 1/10 of the annual subscription: between September 1–5, 2025
- 3rd Payment → 1/10 of the annual subscription: between October 1–5, 2025
- 4th Payment → 1/10 of the annual subscription: between November 1–5, 2025
- 5th Payment → 1/10 of the annual subscription: between December 1–5, 2025
- 6th Payment → 1/10 of the annual subscription: between January 1–5, 2026
- 7th Payment → 1/10 of the annual subscription: between February 1–5, 2026
- 8th Payment → 1/10 of the annual subscription: between March 1–5, 2026
- 9th Payment → 1/10 of the annual subscription: between April 1–5, 2026
- 10th Payment → 2/10 of the annual subscription: between May 1–5, 2026

### Payment Methods:

Payments may be made via bank transfer, debit/credit card (POS), or in cash at the Eurohoops Academy Leonteios front office.

For bank transfers, the athlete's full name must be clearly stated in the payment description.

In cases where services cannot be provided due to force majeure (e.g., natural disasters, public health emergencies) for reasons not attributable to Eurohoops Academy Leonteios, no refunds shall be issued, and subscription payments shall still be required as scheduled..

## Subscription Termination

- a) In the event that an athlete (or their parent/guardian) decides to terminate their subscription,



written notice must be provided via email to: [aoleonteios@eurohoops.net](mailto:aoleonteios@eurohoops.net). If the subscription has been paid in full and there are no outstanding financial obligations up to and including the month of termination, Eurohoops Academy Leonteios will proceed with the deregistration of the athlete, as requested.

b) If the athlete or their parent/guardian fails to notify the Academy in writing via email regarding their decision to terminate the subscription, the athlete will remain officially registered with Eurohoops Academy Leonteios, regardless of their absence or its duration. As such, they will remain liable for the corresponding subscription fees as outlined above.

c) Eurohoops Academy Leonteios reserves the right to replace any deregistered athlete with a new one. Each team has a limited number of spots, and each athlete pays their subscription in order to secure one of those spots. Subscription payment is required for the entire season. An athlete who is deregistered cannot be re-enrolled within the same season.

If a deregistered athlete wishes to re-enroll in a future season, and the original deregistration took place before mid-season (January), they will be required to pay one (1) additional month's subscription fee beyond the month they had already paid.

If the deregistration occurred after mid-season (February), they will be required to pay two (2) additional months beyond the last month paid before they can rejoin.

d) If an athlete has not been officially deregistered but is unable or unwilling to participate in training sessions for any period of time (including for reasons outlined in Article 7, paragraph b), this does not exempt them from the obligation to pay the subscription fee for that period of absence.

e) Failure to pay the subscription fees within the stated deadlines entitles Eurohoops Academy Leonteios to immediately and unilaterally terminate the agreement for the provision of athletic services and to proceed with the athlete's immediate deregistration, without prior notice.

### **3. Medicals**

a) Every athlete wishing to participate in the Eurohoops Academy Leonteios is required to undergo a medical examination by a cardiologist and must submit a valid athlete health card.

b) All home games of the Eurohoops Academy Leonteios held at the Leonteios School facilities are conducted in the presence of staff trained in First Aid. As such, Eurohoops Academy Leonteios cannot be held responsible for any injuries or other incidents occurring during its activities, nor for any resulting medical expenses. Furthermore, the Academy shall not be liable for any direct or indirect damages, moral harm, or emotional distress sustained by the athlete.

c) In the event that an athlete is unable to participate in Academy activities due to injury or illness, they are still required to pay the full subscription fee for that period.

#### **4. Dismissal from Eurohoops Academy Leonteios for Disciplinary Reasons**

- a) In the event of inappropriate behavior by an athlete's parent or legal guardian, Eurohoops Academy Leonteios reserves the right to remove or prohibit them from attending practices or games. Inappropriate behavior is defined as any act or omission that is inconsistent with the philosophy of Eurohoops Academy Leonteios and includes, but is not limited to, conduct in the stands, treatment of other parents (whether from Eurohoops Academy Leonteios or opposing clubs), as well as interactions with the Academy's coaches, staff, or any third parties.
- b) Failure of a parent or legal guardian to comply with the regulations or instructions issued by Eurohoops Academy Leonteios personnel may result in the immediate dismissal of the athlete from the Academy, without prior notice and without any right to a refund of the subscription or claim to any other form of compensation.

#### **5. Audiovisual Material and Intellectual Property**

- a) Any kind of photography, video recording, or audio recording within the premises is strictly prohibited without the permission of Eurohoops Academy Leonteios.
- b) By registering the athlete, you consent to the use and exploitation by Eurohoops Academy Leonteios, the company "Basketball Incubation IKE," the company "Eurohoops Greece IKE," and all partner companies and affiliated organizations of any audiovisual material related to your minor child as may arise in the context of their activities therein.

The Guardian of the athlete, by filling out the "Athlete Participation Application" form, automatically provides their consent for the storage in an electronic archive and use of audiovisual material in which the athlete may appear, as described in paragraph 9 above, within the context of games or training sessions. This material may be used: (a) for monitoring the athlete's athletic performance by the staff of Eurohoops Academy Leonteios, (b) for publication online (on the official website or social media pages of Eurohoops Academy Leonteios and its partner companies, e.g., collaborators, sponsors, etc.). This processing will take place for a period of no more than twenty (20) years from the termination/expiry of the relevant contract, in case the creation of a video showcasing the athlete's progress over the years is desired.

#### **6. Personal data**

**6.1 Identity Information, Birth Certificate, Photos:** In execution of the contract for the provision of athletic services, Eurohoops Academy Leonteios will maintain, in both electronic and paper form, the information of the athlete and the guardian as stated in the "Athlete Participation Application" form. The collection of this data aims to facilitate communication with the athlete and their guardian when necessary (e.g., in case of schedule changes for training sessions, games, etc.). Accordingly, a paper and possibly an electronic record of the submitted birth certificate will be kept, to easily confirm the athlete's date of birth, ensure their proper assignment to the corresponding age group, and ensure lawful participation in age-appropriate competitions. A paper and electronic archive of the athlete's photos will also be maintained so that, in the execution of the contract, identification (e.g., by coaches) is always possible. Lastly, a record will be kept of the days and hours of the athlete's participation in sports activities and their athletic performance during games and/or training sessions (especially statistical performance data such as participation time, successful/unsuccessful shots, etc.); however, biometric data will not be recorded under any circumstances. The data will be stored for a maximum period of five (5) years from the termination/expiry of the relevant contract. An exception applies only to statistics, which are kept indefinitely to maintain historical performance records for the team and the player.

**6.2 Medical Certificates:** Eurohoops Academy Leonteios will maintain in paper and electronic form the athlete's health card submitted upon the signing and/or renewal of the athletic services contract. This processing is necessary for protecting the vital health interests of the athlete and is also a legal obligation of Eurohoops Academy Leonteios. The data will be kept for a maximum period of five (5) years following the termination/expiry of the relevant contract.

**6.3 Electronic Updates on News and Activities of Eurohoops Academy Leonteios:** The Guardian of the athlete, by filling out the "Athlete Participation Application" form, automatically provides their consent for the sending of informational material related to the news and activities of Eurohoops Academy Leonteios to the e-mail address stated in the form. This processing will take place for a period of no more than five (5) years from the termination/expiry of the relevant contract.

**6.4 Other information:** The Guardian or the athlete themselves, under the applicable legal provisions, has the right to submit a request to Eurohoops Academy Leonteios at any time for access, correction, or deletion of their above-mentioned data, or for the restriction of processing, or to object to the processing, or for data portability (transfer to another party). In any case, the Guardian or the athlete also has the right to lodge a complaint before any competent authority for any violation of the applicable data protection laws. It is clarified that the information described in paragraphs 10.1, 10.2, and 10.3 above is essential for the execution of the service provision contract. No automated decision-making and/or profiling of the athlete will occur during the processing of the aforementioned data. The data listed in section 10.1 may be disclosed to third parties, specifically to basketball sports authorities as required by relevant regulations (e.g., to the organizing authority "ESKA") or to opposing teams only when and as required by those regulations.

None of the aforementioned data will, under any circumstances, be transferred to a third country (outside the EU) or to an international organization. With regard to the above, it is clarified that Eurohoops Academy Leonteios is the Data Controller. Its full and accurate legal name is "Eurohoops Academy Leonteios," and its contact details are provided below.

The training sessions and the primary sports facility are located in Patissia, Attica, where any announcements may also be made.

The Data Controller's registered office is located at 17 Neigi Street, Athens.

The legal representative of the Data Controller is the Chairman of its Board of Directors, Mr. Fr Rafa Escola.
