



CHILD PARTICIPATION TERMS
(EDITION 30/07/2026)

1. General Terms of Participation

- a) Eurohoops Move & Grow concerns boys and girls from 4 to 6 years old. The final inclusion of each child in the program is made after an evaluation by the responsible coaches.
- b) The parents/guardians of the children bear the sole responsibility for both their attendance and their departure from the facilities of Leonteios School of Athens (Neigi 17, Athens).
- c) Any change in the training time will be immediately notified to the parents/guardians through the Myteam application, through an announcement on the official website of the Eurohoops Academy Leonteios (<https://aoleonteios.eurohoops.net/>) or via e-mail to the email address stated in the registration form.
- d) The parents/guardians of the children cannot be on the field, unless their presence is deemed necessary by the responsible coaches.
- e) Eurohoops Academy bears no responsibility for any loss of children's belongings and clothing, who are advised not to bring items of significant value or large sums of money with them.

2. Subscription

- a) The subscription to the Eurohoops Move & Grow program concerns the 2026-2027 season (September 2026 – June 2027) and amounts to €30 per month. The subscription includes two training sessions each week and there is no option to choose a different subscription package (e.g. one training session per week).
- b) The number of available places is limited and a first-come, first-served basis will be observed during registration.
- c) The monthly subscription must be paid strictly by the 5th day of each month and is a basic requirement for children to participate in the Eurohoops Move & Grow program.
- d) No refunds will be made under any circumstances.
- e) In the case of siblings registration, a 10% discount is applied on the monthly subscription from the second child onwards.
- f) The monthly subscription is paid either by bank deposit or by debit/credit card (POS) or in cash at the Eurohoops Academy Leonteios secretariat, at Leonteios School of Athens (Neigi 17, Athens, Postal Code: 11143).

In case of payment by bank deposit, the depositor is requested to fill in the child's name in the justification of the deposit.

3. Medical Documentation

- a) For the child's valid participation, the following must be presented:
- Individual health card completed by a pediatrician, accompanied by a photocopy of vaccinations **or**
 - Individual Student Health Card and the health booklet or other evidence proving that the required vaccinations have been received.
- b) The Eurohoops Move & Grow program is conducted in the presence of staff trained in First Aid. Therefore, Eurohoops Academy is not responsible for any injury in the context of its activities nor does it undertake to cover any medical expenses, as well as any positive and/or consequential damage, moral damage and mental anguish.

4. Audiovisual Material

a) Any kind of photography, videography or audio recording is prohibited in the premises of the facilities, without the permission of Eurohoops Academy.

b) By registering your child in this program, you consent to the use and exploitation by Eurohoops Academy, Basketball Incubation IKE, Eurohoops Greece IKE and other collaborating organizations of any audiovisual material related to your minor child as may arise in the context of his/her activities therein. This material may be used: (a) for the monitoring of the child's performance by Eurohoops Academy staff and (b) for publication on the internet (on the official site or on the social networking pages of Eurohoops Academy and its collaborating companies, e.g. partners, sponsors, etc.). This processing will take place for a maximum period of twenty (20) years from the termination/expiration of the relevant contract so that in the event that there is a possibility of creating a video of the progress over the years, the relevant file will exist.

5. Personal data

5.1 Identity details, Birth certificate, Photographs: In execution of the sports services contract, Eurohoops Academy will maintain in electronic and written form the details of the child and the guardian as indicated in the "Athlete Participation Application" form. The collection of said data will be done in order to facilitate communication with the child and his/her guardian as the case may be (e.g. in case of change of training schedule, etc.). In this regard, a paper and possibly an electronic file of the birth certificate provided will be kept in order to easily prove the child's date of birth, his/her correct inclusion in the relevant age sports section. Also, a paper and electronic file of the child's photographs will be kept so that in execution of the relevant contract, his/her identification is always possible (recognition by coaches, etc.). Finally, a record will be kept of the days and hours of the child's participation in sports activities. This data will be kept for a maximum period of five (5) years from the termination/expiration of the relevant contract.

5.2 Medical Certificates: Eurohoops Academy will keep in paper and electronic files the child's individual health card or the student's individual Health Form presented upon conclusion and/or renewal of the sports services contract. This processing is necessary to safeguard the child's vital health interest and is also a legal obligation of Eurohoops Academy. The said data will be kept for a maximum period of five (5) years from the termination/expiration of the relevant contract.

5.3 Electronic information on Eurohoops Academy news and activities: By completing the "Athlete Participation Application" form, the child's guardian automatically gives his consent to the sending of informative material to the e-mail address he declared in the said form in relation to Eurohoops Academy news and activities. This processing will take place for a maximum period of five (5) years from the termination/expiration of the relevant contract.

5.4 Other information: The guardian or the child himself, under the conditions of the relevant legislation, has the right to submit at any time to Eurohoops Academy a request for access and correction or deletion of the above data or for restriction of processing or for opposition to it or for the portability (transfer) of the data to a third party. In any case, the Guardian or the child himself has the right to file a complaint before any competent authority for any violation of the provisions in force in relation to their personal data.

All of the above data will not be transmitted under any circumstances to a third country (outside the EU) or to an international organization. Eurohoops Academy Leonteios is the Data Controller. The training sessions and the main sports area are located in Patisia, Attica, where any notification can be made. The headquarters of the Controller are located at 17 Neigi Street, Athens. The legal representative of the Controller is the Chairman of the Board of Directors, Mr. Fr Rafa Escola. The Data Protection Officer (DPO) is Mr. Emmanuel Kaikousidis (e-mail: dpo@eurohoops.net).
